

Terms & Conditions

Maybank Debit Campaign – Tiger Air 20% discount and Win Free Flight for 2 Promotion

1. **Tiger Air 20% savings and Win Free flight for 2 with Maybank Visa Debit and MasterCard Platinum Debit Card** (“Promotion”) is organized by Malayan Banking Berhad (“Maybank”).
2. This promotion is open only to all Maybank Visa Debit including Co Brands and MasterCard Platinum Debit Cardholders (“Cardholders”) during the Promotion Period.
3. This campaign shall be applicable to all new and existing Maybank Visa Debit and MasterCard Platinum Debit cardholders including cardholders that renew or replace their Debit card at any Branch excluding employees of Maybank Debit, Prepaid & Innovation, Cards Marketing, its partners, advertising agencies, auditors including their immediate family members and any other persons involved in organizing, promoting and/or conducting this Promotion.
4. Cardholders whose accounts with Maybank which have been suspended, closed or who are in breach of their Agreement with Maybank shall not be eligible for the Promotion or the Prizes.

Promotion Period

5. The Promotion commences for Booking from 26th May 2014 to 15 June 2014 and travel period will commence from 1st July 1 to 25th October 2014 (“Promotion Period”), both dates inclusive.

Qualification Mechanics

7. The Tiger Air 20% saving and Win Free flight for 2 is open to all Maybank Visa Debit and MasterCard Debit cardholders.
8. 20% saving is applicable to the selected destination when a one way or return ticket is purchased during the Booking period via online only.
9. To win the 3X weekly prize for 2, Maybank Debit cardholders need to register Once via SMS to MDCTAIR<space> 12 digit NRIC sent to 66628. To qualify for entry, Maybank Debit cardholders must have any amount purchase made via Online at Tiger Air.
