## Reload & Win Promotion @ Maybank

### Terms & conditions

1. DiGi Telecommunications Sdn Bhd (201283-M) ("DiGi") and Maybank ("Maybank") will be jointly running a reload DiGi Prepaid promotion ("the Promotion") commencing from 12:01 a.m., 2nd May 2011 until 11:59 p.m., 24th July 2011 (both days inclusive) ("Promotion Period")
2. **Eligibility**
  - All individuals residing in Malaysia are eligible to participate in the Promotion.
  - This Promotion is open to all Maybankard Bankcard cardholders and Maybank2u.com users.
  - The following are not eligible for the Promotion:
    - a. Employees of DiGi Telecommunications Sdn. Bhd. and their immediate family members
    - b. Employees of DiGi's partners, advertising, promotion agencies and any other persons involved in organizing, promoting and/or conducting the Promotion and their immediate family members;
    - c. Staff of the Wealth & Payment and Virtual Banking of Maybank will not be eligible to participate in this Promotion. (hereinafter referred to as "the Participant")

  - b. All DiGi Prepaid subscribers are entitled to win the Freebies with the exception of all Prepaid Internet plan subscribers.

DiGi and Maybank shall not be liable for any loss or damage (including without limitation loss of income, profits or goodwill, direct or indirect, incidental, consequential, exemplary, punitive or special damages of any party including third parties) howsoever arising whether in contract, tort, negligence or otherwise, in connection with the Promotion, even if DiGi and Maybank has been advised of the possibility of such damages in advance, and all such damages are expressly excluded.

32. In the event any discrepancies or disputes in the interpretation between the English and the Bahasa Malaysia of these term and conditions, the English version of these terms and conditions shall prevail.
