Terms & Conditions

WU@M2U Send & Win Cash Contest ("Contest") is organised by Malayan Banking Berhad (3813-K) ("Maybank") and shall be subject to the Terms and Conditions herein. By participating in this Contest, the Eligible Participants (as defined in Clause 1 below) hereby expressly agree to be bound by these Terms & Conditions and any decisions made by Maybank in respect of the Contest shall be final and binding.

1.0 Eligibility

- a) This Contest is open to all account holders of Maybank's or Maybank Islamic Berhad's savings or current account who have an active Maybank2u (M2U) registered account.
- b) This Contest is open for individuals who are eighteen (18) years of age and above with valid identification document. Only the primary account holder of a joint account will be eligible to participate in the Contest.
- c) For new individual customers who sign-up for a Maybank or Maybank Islamic Berhad's savings or current account during the Contest Period (as defined in Clause 2 below), his/her qualifying transactions for the purposes of this Contest will only take effect upon activation of his/her Maybank2u account.
- d) All individual customers who have fulfiiled the above criteria will hereinafter referred to as the "Eligible Participants".
- e) Employees of Maybank and its group of companies are eligible to participate in this Contest except for employees of Maybank2u, Virtual Banking & Payments, advertising and promotions agencies who are directly involved in the promotion of the Contest as well as their immediate family members.

2.0 Contest Mechanics and Conditions

- a) This Contest commences on **1 October 2017 and ends on 31 March 2018** ("Contest Period").
- b) During the Contest Period, the Eligible Participants are to perform as many Eligible Transactions as possible. The Eligible Transactions are as shown in Table 2.0 below.

3.0 Prizes

The prizes for the Contest are as shown in Table 3.0 below:

Prize(s) is/are non-transferable and will be credited into the winner's savings or current account maintained with Maybank or Maybank Islamic Berhad as selected and notified by Maybank.

- e) An Eligible Participant must have an existing Maybank or Maybank Islamic Berhad's savings or current account.
