TERMS AND CONDITIONS

Organizer & Qualifications

- 1. "Dekat lagi Murah, MyDebit dan Menang!" ["Contest"] is jointly organized by 99SPEEDMART Sdn Bhd 519537-X and Payments Network Malaysia Sdn Bhd 836743-D (formerly known as Malaysian Electronic Clearing Corporation Sdn Bhd) (for MyDebit) ["The Organizer"] and is open to permanent residents in Malaysia or Malaysian citizens with a valid identity card during the Contest Period ["Participant"]
- 2. Individuals listed below are not eligible to participate in this Contest:
