## **Terms and Conditions**

- 1. I/We hereby undertake to reimburse you all payments made or to be made by you under this BPO-i, even if the merchandise be diverted or over-carried or failed to arrive or be refused landing at the destination due to whatever cause.
- 2. I/We hereby agree to pay your commission and all expenses and your agent's charges.
- 3. You are to have a lien on all goods, documents and policies and proceeds the of will full power of sale over said goods, for any obligations or liabilities present or future incurred by you under and arising out this BPO-i.
- 4. I/We hereby undertake to purchase the goods from the Bank upon delivery of the goods or under documents called for/required by the Bank under this BPO-i.
  - Note: This condition is only applicable to BPO-i (with Murabahah financing)
- 5. You may at your absolute discretion and without giving notice to me/us convert into local currency equivalent, all drafts and documents negotiated under this credit at the prevailing rate of exchange at any time after the receipt of cable of negotiation or the receipt of the relative draft and documents, unless otherwise, arranged.
- 6. I/We certify that the imports of the relevant goods are permissible and shariah-compliant, not prohibited or restricted and that I/We hold and undertake a valid license where such license is required.
- 7. I/We hold you and your agents free from any responsibility for any delay, mistake or omission that may happen in the transmission of the instructions or their misinterpretation when received and for the correctness or genuineness of the documents submitted if apparently in order or for the loss or delay in forwarding of the documents.
- 9. You are authorised to earmark/debit my/our account for the required marginal deposit as determined by you and such additional deposit as may be demanded form time to time and to retain such sum and to apply the same by:
  - a) setting off the same against the amount due on the draft(s) drawn under this BPO-i or any other monies due to you hereunder;
  - b) crediting it to yourselves against any indebtedness which may now exist or hereafter raised by me/us to you in respect of any other dealing or transaction between us
  - And it is agreed and understood that I/We shall not be entitled to claim the refund of the said deposit until and unless any other indebtedness by me/us to you in respect of any other account dealing or transaction between us have been settled.
- 10. You are hereby authorised to debit my/out account without prior notice to us any payments made by you and/or the amount of any draft accepted by you at the time of such acceptance or before maturity to our accounts with you and all your charges, commission and out-of-pocket expenses including charges levied by your correspondents or agents.
- 11. This BPO-i is subject to the Uniform Rules for BPO-i (URBPO), International Chamber of Commerce (ICC) Publication No. 750 insofar as these are applicable at the date of this application.
