6. I/We certify that the imports of the relevant goods are permissible and shariah-compliant, not prohibited or restricted and that I/We hold and undertake a valid license where such license is required.

I/We hold you and your agents free from any responsibility for any delay, mistake or omission that may happen in the transmission of the instructions or their misinterpretation when received and for the correctness or genuineness of the documents submitted if apparently in order or for the loss or delay in forwarding of the documents.
