What is CGC Schemes?

This is a working capital and CAPEX financing in the form of Term Loan, Overdraft and Tradelines introduced by CGC for SMEs. The scheme has 2 options, i.e. BizJamin Scheme and Flexi Guarantee Scheme.

The interest rate charged for BizJamin Scheme is calculated based on variable rates basis while BNM funding rate will be used for Flexi Guarantee Scheme. Letter of guarantee by directors (applicable for Sdn Bhd) and CGC guarantee will be taken as collateral/security for the financing.

Know Your Obligations

BizJamin

- Your financing amount: RM500,000
- Your monthly instalment: RM6,173
- Your financing tenure: 10 years
- Interest rate: BLR + 2.00% p.a.
(Currently, the BLR 6.40%)
- Effective interest rate: 8.40%

In total, you will pay RM740,709 at the end of 10 years

You have to pay the following fees & charges:

- Stamp duty: 0.5% of financing amount
- Guarantee Fee (for BizJamin only): Range from 0.75% to 4.00%
- Commitment Fees: 1% p.a. is to be levied on utilised portion of overdraft facility
- Excess fee on Overdraft (OD): 1.00% p.a.
- In-House Legal Documentation Charges: Documentation fee is waived
- Disbursement fee: NIL
- Late payment charge: 1% per annum on the amount in arrears

Pay your monthly instalment timely and in full for **10 years**. Speak to us if you wish to settle your loan earlier.



Contact us immediately if you are unable to pay your monthly instalment.
