**NEW PREMATURE WITHDRAWAL RULES FOR CONVENTIONAL FIXED DEPOSIT**

Please be informed that with effect from 1 January 2019 (“Effective Date”), the new premature withdrawal rules for all existing, renewed and new placements of Conventional Fixed Deposit are as follows:-
