PARTICULARS OF PROPERTY

BRIEF PARTICULARS

1.0 Location and Surrounding

The subject property is situated within Lumut town centre and is easily accessible via various roads within Lumut town centre such as Jalan Nakhoda Mohd Taib and Jalan Pegawai onto Jalan Sultan Idris Shah to where the subject property is sited.

The subject property is also situated approximately 8.8 kilometres due north-west of Seri Manjung town centre. Access to the subject property from Seri Manjung town centre is via Jalan Iskandar Shah for about 8.6 kilometres before turning left onto Jalan Sultan Idris Shah for about 200 metres to where the subject property is sited

The subject property is identified as No. 10 & 12, Jalan Sultan Idris Shah, 32200 Lumut, Perak.

The subject property is located within a commercial area of Lumut town centre comprises mainly of single, double and three storey shop offices and pre-war shop houses.

Notable landmarks found in the immediate area are Lumut post office, waterfront promenade, Lumut Ferry Jetty and tourist information centre.

Lumut town being a coastal town in Manjung district is the main gateway to Pangkor Island and businesses and activities in the area are centered on tourism. The town has also become the home based of the Royal Malaysia Navy and the site of biggest naval shipbuilder in Malaysia, Boustead Naval Shipyard.

Housing developments found in the larger areas includes Lumut Valley condominium, Titi Panjang apartment, Desair apartment and Taman Desa Manjung to name a few.

Bandar Baru Seri Manjung serves as the administrative and commercial centre for the district of Manjung and provides all basic necessities such as banking, shopping

2.0 Property Description

The subject property is two (2) adjoining units of double-storey shopoffice known as No. 10 & 12, Jalan Sultan Idris Shah, 32200 Lumut, Perak

a) Site

The sites are two (2) intermediate lots of rectangular in shaped with a frontage width of about 6.096 metres (20 feet) each onto Jalan Sultan Idris Shah and a maximum depth of about 30.448 metres (99.9 feet) each. Each site covers an area of about 185.62 square metres (1,998 square feet).

The land is flat and lies at the same level with the existing frontage metalled road, Jalan Sultan Idris Shah.

b) Building

Basically, the building is constructed of reinforced concrete frame framework with cement sand bricks wall plastered and painted supporting pitch roof with timber trusses covered with cement roofing tiles.

The main entrances to the subject property are secured by dual leaf glass door, whilst the other internal doors are of timber / plywood flush doors, roller shutter and glass door with timber or aluminium framed.

The windows are of aluminium casement with tinted glass for the main façade of the building, whilst the rest of the windows are of aluminium casement with glass secured with iron grilles and bars.

The flooring is of reinforced concrete supported with concrete foundation for the ground floor and reinforced concrete slabs for the upper floors.

The vertical access within the subject property is via two (2) reinforced concrete staircases located at the front and rear portions of the building.

The ceilings are generally of flat sheets and the floor finishes throughout the building are of ceramic tiles except for the airwell which of cement rendered.

We noted that the partition walls on ground and first floors between the two buildings have been demolished to provide larger banking and office areas.


