Airport Lounge Access

- The complimentary airport lounge access defined below is only applicable for principal Maybank World Elite Mastercard and Maybank Islamic World Elite Mastercard Ikhwan cardholders.
- Each principal cardholder is entitled to sixteen (16) total complimentary visits per calendar year at the participating lounges, as set out below:

- Lounge access are awarded every six (6) months per calendar year basis. Any unutilized lounge access will be forfeited and cannot be carried forward to the following six (6) months.
- One (1) accompanying guest is permitted per visit to the lounge, on the condition that the principal cardholder is present and holds a valid boarding pass.



- Enjoy up to three (3) hours lounge use, including food & beverages, internet access, international newspaper & magazines, international TV channels, shower facilities with amenities and flight information (subject to respective airport lounges).
- Lounge visits are limited to one (1) visit per day.
- Cardholders must present their principal Maybank World Elite Mastercard or Maybank Islamic World Elite Mastercard Ikhwan with a valid boarding pass upon arrival to the lounge, subject to availability of space within the lounge.
- Applicable charges will be applied by the lounge provider or back-charged by the Bank into the cardholders' account, in the following situations:
 - a) Any subsequent visits once a principal cardholder has fully utilized the allotted complimentary visits.
 - b) Any visits by supplementary cardholders (who are not entitled to complimentary lounge access), unless entering as an accompanying guest of a Principal cardholder;
 - c) For a) visits exceeding the allotted complimentary access and/or b) visits by supplementary cardholders who are not entitled, cardholders will receive a 20% discount off the published walk-in rate.
- Maybank / Maybank Islamic reserves the right to charge the full cost of the lounge visit to the principal cardholder's account if a supplementary cardholder is found to have entered a lounge using a principal cardholder's complimentary access allocation without payment.
- Terms and conditions of the respective lounges apply.
