Maybank2U Challenge

Terms & Conditions

Maybank2U Challenge ("Contest") is organised by Malayan Banking Berhad (3813-K) (inclusive of its Group of Companies) ("Maybank") and shall be subject to the Terms and Conditions herein. By participating in this Contest, the Eligible Participants (as defined in Clause 1 below) hereby expressly agree to be bound by these Terms & Conditions and any decisions made by Maybank with respect to the Contest shall be final and binding.

1.0 Eligibility and Platform

- a) This Contest is open to all Maybank2U Individual and Sole Proprietor customers in Malaysia ('Eligible Participants').
- b) This Contest is only accessible through the new Maybank website (www.maybank2u.com.my) and Maybank App ("Contest Platforms").
