Promotion Terms and Conditions

1. Definition

- (a) **“Additional Terms and Conditions”** means the terms and conditions that govern the Promotion (if any) as determined by the Participating Banks.
- (b) **“FPX”** means a national initiative supported by Participating Banks that allows real-time debiting of customer’s internet banking account of multiple banks and direct crediting into merchant’s account by banks. FPX service is suitable for all businesses that offer products or services via the Internet
- (c) **“FPX Merchant”** means merchant that have registered to participate in FPX.
- (d) **“FPX Transaction”** means the successful payment of any of a FPX Merchant via FPX. The minimum FPX Transaction for retail payment (B2C) and for corporate payment (B2B) is RM5. The FPX Transaction is to be carried out during the Promotion Period through any preferred Internet or Mobile Banking of the Participating Banks.
- (e) **“Organizer”** means Payments Network Malaysia Sdn. Bhd. (Company No.836743-D) and The National ICT Association of Malaysia (PIKOM).
- (f) **“Participating Banks”** means the list of Banks as set out in Table 1 below.
- (g) **“Participating Third Party Acquirers”** means the list of Third Party Acquirers as set out in Table 2 below.
- (h) **“Prizes”** means the prizes set out in Clause 4 below.

2. Promotion Period

- (a) The Promotion shall run from 00:00 hours (GMT+8) on 17 July 2019 until 23:59 (GMT+8) hours on 3 October 2019 (both dates inclusive) (**“Promotion Period”**).

3. Eligibility and Qualifying Criteria

- (a) This Promotion is open to all customers who perform the FPX Transaction(s) during the Promotion Period at any website or mobile application of all Participating FPX Merchants, with a valid identification document (example: identity card or passport) (**“Eligible Customers”**).

- (b) Splitting payment for any invoices/bills for this Promotion is strictly not allowed. For eg, if you are paying bill/invoice amounting to RM90, you are not allowed to split payment into 3 split transaction of RM30. Split transactions will not be counted or eligible for winning any prizes
- (c) FPX Transactions which are incomplete or performed before or after the Promotion Period shall not be accepted and will not be eligible to participate in this Promotion.
- (d) The eligibility requirements to participate in this Promotion are as follows :
 - i. Only customers who are above eighteen (18) years of age shall be eligible to participate;
 - ii. Its’ affiliates and related companies, directors, officers and employees as well as their parents, spouse and children of the Organizer are not eligible to participate in this Promotion nor to win any Prizes;
 - iii. Customers’ that hold any accounts with the Participating Banks shall NOT be terminated, suspended, cancelled or dormant within the Promotion Period;
 - iv. Customers that hold any accounts with the Participating Banks shall NOT be delinquent or unsatisfactorily conducted as determined by the Participating Banks at its sole and absolute discretion;
 - v. Customers who have NOT become insane, declared bankrupt or have legal proceedings of any nature instituted against them shall be eligible to participate.

5. Shortlisting of Winners

- (i) All decisions made by the Organizer, the Participating Bank and/or TPA in relation to the Promotion including but not limited to the shortlisting, selection of winners and forfeiture of the Prizes shall be final, conclusive and binding.
- (j) This Promotion Terms and Conditions shall be read together with the Additional Terms and Conditions of each Participating Bank (if any) **(collectively, “Terms and Conditions”)**.
- (k) By participating in the Promotion, Eligible Customers agree to be bound by the Terms and Conditions stated herein. The Promotion Terms and Conditions shall prevail over any inconsistent terms and conditions contained in the Additional Terms and Conditions and/or in any other promotional or advertising materials for the Promotion. In the event of any inconsistency between the English and Bahasa Melayu (if any) version, the English version shall prevail.
- (l) Additional Terms and Conditions by Participating Banks are available at the respective Participating Bank’s websites.
