

"MORTGAGE WITH US, CASH REWARDS ON US" FY2021 CONTEST TERMS AND CONDITIONS

- 1. The "Mortgage with Us, Cash Rewards on Us" contest (hereinafter referred to as "the Contest") commences on January, 2021 and shall end on 31 December 2021 ("the Contest Period").
- 2. The Contest is open to eligible existing Malayan Banking Bhd ("Maybank") and or Maybank Islamic Bhd ("Maybank Islamic") customers of good standing as may be determined by Maybank/ Maybank Islamic at its sole and absolute discretion.
