Terms & Conditions

- IV. M2C Premier cards (American Express Reserve)
- V. All Visa Infinite Cards
- VI. All Maybank World Mastercard
- VII. Visa Signature Card (not inclusive of Visa Signature Barcelona card)
- VIII. American Express® Platinum Credit Card

Principal and Supplementary ("Cardmembers") which are valid, subsisting and in good credit standing as may be determined by Malayan Banking Berhad (Co. No. 3813-K) at its sole and absolute discretion. Supplementary spend will be accumulated and consolidated to the Principal card spend.
