TERMS AND CONDITIONS

Organizer & Qualifications

- "<u>MyDebit Je Dengan Kad ATM Anda Dan Menang</u> ["Contest"] is jointly organized by Mydin Mohamed Holdings Berhad (Company No: 199101011136) (221448-A) and Payments Network Malaysia Sdn Bhd (Company No: 2000801035403 (836743-D)) (PayNet) ["The Organizer"].
- 2. The Contest is open to all MyDebit Automated Teller Machine ["ATM"] card holders issued by participating financial institutions authorizing MyDebit services in Malaysia. The mentioned card holders must be a permanent resident in Malaysia or a Malaysian citizen who is 18 years of age and above and has a valid identification card during the Contest Period ["Participant"].
