

Terms & Conditions

The “Debit & Win Cash Back with Maybank Mastercard® Debit Card!” (“Campaign”) is organized by Malayan Banking Berhad (“Maybank”) and is subject to these Terms and Conditions. By participating in this Campaign, the Eligible Cardmembers (as defined below) hereby expressly agree to be bound by these Terms & Conditions and the decisions made by Maybank in respect of the Campaign shall be final, conclusive and binding.

1. ELIGIBILITY

- 1.1 This Campaign is open to all Maybank Mastercard Debit Cardmembers (“Eligible Cardmembers”) during the Campaign Period as defined below.
