



Shopee 10.10 (“**Campaign**”) is organised by Malayan Banking Berhad (Co. No.196001000142) (Malayan Banking Berhad is collectively referred to as “**Maybank**”) and Shopee Mobile Malaysia Sdn. Bhd. (Company No. 1134832W) (“**Shopee**”). This Campaign shall be subjected to these Terms and Conditions. By participating in this Campaign, Eligible Customers (as defined in Clause 1.0 below) hereby expressly agree to be bound by these Terms & Conditions. The decisions made by Maybank in respect of the Campaign shall be final, conclusive and binding.

1.0 Eligibility

- a) This Campaign is open to all individuals who have an active Maybank2u (“**M2U**”) registered account and all Shopee users with valid Shopee accounts. (All individual customers who have fulfilled the above criteria will hereinafter be referred to as (“**Eligible Customers**”).
- b) This Campaign is open to individuals who are eighteen (18) years of age and above with valid identification documents. For individuals below the age of eighteen (18) years (“**Minor**”), they must obtain consent from their parents and/or legal guardian in order to participate in this Campaign. These Terms and Conditions will be equally applicable to their parents and/or legal guardian in substitution of the applicability of these Terms and Conditions on the Minor. By participating in the Campaign, the Minor is deemed to have obtained the necessary consent.
- c) This Campaign is open for the first time and existing users who link their Maybank accounts with Shopee account and checkout a minimum value of RM50 on the same day to be eligible for the Complimentary Shipping Voucher.
- d) This Campaign is only valid for Shopee Malaysia. Any transaction made outside of Shopee Malaysia will not contribute towards or be considered for this Campaign.

2.0 Campaign Mechanics, Duration & Reward

- a) This Campaign will commence on 20 September 2021, at 12:00:00 AM and ends on 10 October 2021, at 23:59:59 PM (both dates inclusive) or when the Promo Voucher(as defined below) is fully awarded, whichever is earlier (“**Campaign Period**”).
- b) This Campaign comprises of **3 stages**, as follows:
 - **Link-up AND checkout:** 20 September 2021 - 8 October 2021
 - **Voucher Crediting:** 9 October 2021
 - **Voucher Redemption:** 10 October 2021
- c) Eligible Customers will receive a Complimentary Shipping Voucher with minimum spend of RM50(capped at RM6 for the first 10,830 total users i.e. 570 daily) (“**Promo Voucher**”) on the Shopee App or Shopee Website (“**Campaign Platform**”).
- d) Each Eligible Customer will enjoy a Promo Voucher on Shopee:
 - when they link-up their Shopee account with their respective Maybank accounts i.e. Current, Savings account ; **AND**
 - when they checkout from their Shopee account using the linked Maybank2u account as payment option with a minimum amount of RM50 between 20

September 2021 - 8 October 2021 (checkout via FPX is excluded from Campaign)(“Eligible Transaction”);

- e) In order to utilise the Promo Voucher awarded, the Eligible Customer must checkout with the credited Promo Voucher via the Campaign Platform with a minimum spend of RM40 with all payment methods on 10 October 2021 to redeem the Promo Voucher.

- Promo Voucher is valid on Shopee Mall & Preferred Sellers via Shopee app checkouts only, applicable to the above payment methods.
- Promo Voucher is not applicable on Baby Formula, Food & Supplements, Diapers & Potties, Tickets & Vouchers, Mobile Reloads & Sim Cards, Top-ups, S-Mart Milo, One or Not by Shopee Store products, MMA Foundation Store products and PETRONAS & Setel Fuel Cards, Gift Cards & E-Voucher.
- Promo Voucher is not refundable, non-transferable, and is not redeemable for cash or kind.

- i) One Eligible Customer is only entitled to **one (1)** Promo Voucher within the Campaign Period regardless of how many times they checkout.
