Maybank Manchester United TikTok Challenge 2024

The Maybank Manchester United TikTok Challenge 2024 ("Challenge") is organised by Malayan Banking Berhad (196001000142) ("Maybank"). By participating in this Challenge, the Eligible Participants (as defined in Clauses 2 below) hereby expressly agree to be bound by these Terms & Conditions and any decisions made by Maybank in respect of this Challenge shall be final and binding.

- 1. The Challenge commences on 1st November 2024 and ends on 31 January 2025, both dates inclusive ("Challenge Period").
- 2. This Challenge is open to all Malaysian citizens who are of eighteen (18) years old (proof of age may be required) ("Eligible Participants").
- 3. Employees of Maybank are eligible to participate in this Challenge.
- 4. Eligible Participants must meet the following requirements:
 - a. Required to have a TikTok account with privacy settings set to "public";
 - b. Upload a video recreating favorite Manchester United match day experience, which can include pre-match rituals, watching the game, celebrating goals, or post match reaction with TikTok App ("the Entry");
 - c. Use the hashtag #MUFC and #MaybankCards #MBBChallenge when uploading the video;
 - d. Tag Maybank (@mymaybank) on the uploaded video; and
 - e. Videos can be in Bahasa Malaysia, Mandarin or English.

(Collectively, the "Qualifying Steps")

- 5. Multiple entry is allowed with different content. However, only one entry will be selected based on the highest view count. Eligible Participants found manipulating the entries (for instance, creating shell social media accounts to take part in the Contest) will be disqualified immediately.
- 6. Eligible Participants must ensure their profile, video submission, comments and direct message functions on TikTok are open to public to ensure visibility and be contactable for verification purposes.
- 7. No responsibility is accepted for any contest entries that are incomplete, tagged incorrectly, unreadable, ineligible, corrupted, misdirected, lost or delayed or are unable to be sent/published due to technical or transmissions failures of any kind or any other reason.
- 8. Any cost associated with entering the Challenge is the Eligible Participant's responsibility.
- 9. Each Eligible Participant warrants that its entry submission is the original work of the participant and, as such, the participant is the sole and exclusive owner and rights holder of the submitted work, and that the participant has the right to submit the work to the

Challenge and grant all required licenses. Each Eligible Participant agrees not to submit any entry that:

All entries submitted must NOT contain material which is (or promotes activities which are) sexually explicit, obscene, pornographic, violent (e.g., relating to murder, the sales or use of weapons, cruelty, abuse, etc.), discriminatory (based on race, sex, religion, natural origin, physical disability, sexual orientation or age), illegal (e.g. underage drinking, substance abuse, computer hacking, etc.), offensive, threatening, profane, or harassing or which is otherwise inappropriate, in the sole discretion of the Maybank, nor may the name submitted contain any derogatory references to Maybank or any other person or entity including brands or trademarks of Maybank or any other person or entity.
- 11. Eligible Participants shall not remove their video submission at any time prior to prize fulfilment to prevent forfeiture.
- 12. Eligible Participants grant to Maybank the perpetual, exclusive right to use any videos and/or other material submitted for the Challenge for advertising, marketing and communication purposes without compensation to the Eligible Participants.

- 14.
