

Western Union New Users Campaign 2023 - Terms and Conditions

Western Union New Users Campaign 2023 (“**Campaign**”) is organised by Malayan Banking Berhad (196001000142) and Maybank Islamic Berhad (200701029411) (collectively known as “**Maybank**”). The Campaign is subject to these Terms and Conditions. By participating in this Campaign, Eligible Customers (as defined in Clause 1 below) hereby expressly agree to be bound by these Terms & Conditions and all the decisions made by Maybank in respect of this Campaign shall be final and binding.

1.0 Eligibility

- A. This Campaign is open to selected Maybank customers with an active Maybank2u (M2U) ID/account who receive an invitation from Maybank to participate in this Campaign through push notification/EDM during the Campaign Period. (“**Eligible Customer(s)**”)
