

Tiger Tabung Giveaway Contest - Terms and Conditions

MAE Exclusive **Tiger Tabung** Giveaway Contest (“**Contest**”) is organised by Malayan Banking Berhad (Registration No.: 196001000142) (“**Maybank**”) and shall be subjected to the Terms and Conditions herein. By participating in this Contest, Eligible Participants (as defined in Clause 2.0 below) hereby expressly agree to be bound by these Terms and Conditions and any decisions made by Maybank in respect of the Contest shall be final and binding.

1.0 Contest Period

This Contest commences on 18 August 2025 at 12.00:00 AM (MYT) and will end on 24 August 2025 at 11:59:59 PM for the Contest Mechanic listed in the Clause 3.0 below unless notified otherwise.

2.0 Eligibility

- (a) This Contest is open to individuals who have an active Maybank Anytime Everywhere by Maybank2u (“**MAE**”) account and a **MAE Tabung** who perform the Eligible Actions (as stated in the Contest Mechanics and Conditions in Clause 3.0) through Maybank’s official Facebook page (@Maybank) (“**Eligible Platform**”).
- (b) All individual participants who have fulfilled the above criteria and have carried out successful “**Eligible Submission**” (as stated in the Contest Mechanics and Conditions in Clause 3.0(a)) will hereinafter be referred to as “**Eligible Participants**”.
- (c) This Contest is open to individuals who are eighteen (18) years of age and above with valid identification documents (NRIC for Malaysian citizens, Passport for foreigners). For individuals below the age of eighteen (18) years (“minor”), they must obtain consent of their parents and/or legal guardian in order to participate in the Contest. The use of the MAE App and MAE account indicates an acknowledgement to Maybank that the minor has obtained the prior consent of his or her parents and/or legal guardian.

- (e) Eligible Participants must ensure their direct messages on Facebook are open and public to be reachable for contact upon verification and prize fulfilment (if applicable).
