

Registration of Interest with Participating Banks

1. Introduction

- 1.1 The Registration of Interest (“**ROI**”) with Participating Banks (“**Promotion**”) is organized by Samsung Malaysia Electronics (SME) Sdn Bhd [Company No. 200301026766(629186-D)] (“**Samsung**”).
- 1.2 The sales transaction in the Promotion is between the Participating Stores (as defined below) and Customer. Samsung only provides the recommended retail price (“**RRP**”) and/or redemption guidance on this site.
- 1.3 Customer agrees to comply with all the terms and conditions. The scope of these Terms and Conditions is limited to Samsung's role of organizing this Promotion only.
- 1.4 The Promotion is on a first come first served basis, and while stocks last.

2. Promotion Period

- 2.1 The Promotion will run from 8 July 2026 (7.00am onwards) to 22 July 2026 or while promotional stocks last, whichever is earlier (“**Promotion Period**”).
- 2.2 The Redemption will run from 22 July 2026 (9.00pm onwards) to 4 October 2026 or while promotional stocks last, whichever is earlier (“**Redemption Period**”).
- 2.3 Samsung reserves the right to shorten, extend or cancel the Promotion/Redemption Period at its sole discretion without prior notice.

Step 3	Key in the Bank ROI Voucher code to redeem (RM120 will be deducted to the Participating Models) and complimentary gift will be auto-added into the cart.
Step 4	At the checkout page, make payment by Maybank’s debit or credit card in the same single transaction. Note: The Bank ROI Voucher and the payment debit or credit card shall be from the same bank. For eg. if the eligible Customer is directed from Maybank to

	complete the ROI and received/redeemed the Bank ROI Voucher, payment shall be made using Maybank debit or credit card too.
